2. The tournament will be launched on October 13, 2018 (Saturday) at 8:00 AM at Lapu-Lapu City Auditorium, Lapu-Lapu City the host Division for this year's tournament. It will start with the Registration, to be followed with a simple parade, short program, search for Miss DERESA 2017 and game proper in the afternoon. Each team shall be responsible of their own provisions.

3. FIBA, FIVB, Lawn Tennis, Chess, Table Tennis, Billiard, Dart, Badminton Rules shall be followed respectively, however, the committee can modify the rules as the need arises. The Committee's decision is, at all times, final.

During Registration, the team shall:

- * be in complete line-up wearing the tournament uniform.
- * bring all the requirements (official line-up, Medical Certificate/waiver, certificate of Employment, DepEd I.D.-photocopy and duly accomplished membership form).
 *must pay the registration fee of :
 - A. Basketball P 8,000.00/category B. Volleyball P 7,000.00/category C. Badminton P 3,200.00/category D. Table Tennis ... P 2,000.00/category E. Lawn Tennis P 2,000.00/category G. Billiard P 1,000.00 only H. Dart P 1,000.00/category I. Sepak Takraw .. P 2,000.00/category

5. All participating teams are required to attend the opening parade and program at Lapu-Lapu City Auditorium this coming October 13, 2018 (Saturday). Failure to attend the parade and opening program a 10 points plus to their opposing team on the first game and plus 5 points on the succeeding game until the end of the elimination round.

6. Registration and membership fee shall be paid on or before the opening day through DepEd RO7 Multi-Purpose Cooperative.

7. The registration fee, uniform and transportation expenses and other relative to these activities shall be from <u>personal/stakeholders</u> funds or may be charged against <u>Region/Division</u> <u>MOOE/SEF/PTA/GAA/GAD/ or other</u> funds subject to the usual accounting and auditing rules and regulations.
