1. The 2013 *Palarong Pambansa* will be held at the Governor Mariano Perdices Memorial Coliseum, Dumaguete City on April 21-27, 2013.
2. The composition of the *Palarong Pambansa* Board and National Executive Committee; and the designation of chairpersons of the various management working committees under the Technical Management and Administration (TMA) is enclosed.
3. The list of members of the committees shall be identified in a separate memorandum upon the completion of an objective selection process in consultation with the identified chairpersons. Umali, as Secretary-General of the 2013 *Palarong Pambansa*, is hereby directed to convene the chairpersons of the various committees under the TMA to identify the members of their respective committees.

6. All officiating officials to be designated must attend the Opening and Closing Programs and the Refresher Course. Those who fail to register on April 17, 2013 or those who fail to attend the refresher course shall be replaced by the TMA Committees following the criteria set forth in the selection of officiating officials.
7. All members of the TMA Committees shall observe the "No Alcohol, No Smoking and No Gambling policies of this Department during the Palaro. Violators shall be dealt with accordingly.
8. Transportation expenses of all members of the TMA Committees from their respective stations to Gov. Mariano Perdices Memorial Coliseum and back shall be charged to DepED OSEC Funds subject to the usual accounting and auditing rules and regulations. **All officers and members of the TMA must use the most economical and austere means of transportation.**
