

**ADDITIONAL GUIDELINES ON THE ADMINISTRATION OF THE SCHOOL READINESS
YEAR-END ASSESSMENT (SReYA)**

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary Schools
All Others Concerned

1. For the information and guidance of all concerned, the following additional guidelines are set relative to the **Administration of the School Readiness Year-End Assessment (SReYA)**:

- a. The School Readiness Year-End Assessment (SreYA) shall be administered to all children who have undergone the Kindergarten Education Program not later than **March 31, 2013**;
- b. All teachers handling Kindergarten classes under the Kindergarten Regular Program (KRP) and the Kindergarten Volunteer Program (KVP) including their respective principals/school heads (SHs) shall be provided with orientation training on the administration of SReYA;
- c. The division team composed of the supervisor-in-charge of Kindergarten, principals/school heads (SHs), and Kindergarten teacher who attended the *Training of Trainers (TOT) on the SReYA Administration* in February 2013 is expected to conduct an *echo training* with the support and supervision of the regional coordinator-in-charge of the Kindergarten Education Program on or before **March 8, 2013**; and
- d. The resources needed to conduct the said orientation training may be sourced or charged to local Maintenance Operating and Other Expenses (MOOE) and/or Special Education Fund (SEF) subject for replenishment upon the issuance of the Sub-Allotment Release Order (SARO) from the Central Office (CO).

2. The children enrolling in Grade I who are transferees from private schools and Day Care Centers, including children who have not undergone Kindergarten Education Program shall be given assessment using the old version of the School Readiness Assessment being administered by the Grade I teachers to determine their school readiness and for instructional purposes.

3. For the purpose of reporting, the division office (DO) through the regional office (RO) shall submit to the Bureau of Elementary Education (BEE), DepEd Central Office the SReYA results indicated in DepEd Order No. 5, s. 2013.

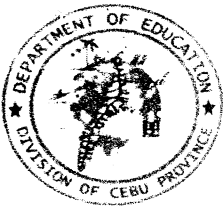
