CEBU TERTIARY EDUCATION ASSISTANCE PROGRAM (CTEAP)

TO: OIC, Assistant Superintendents

Education Supervisors/Coordinators

Secondary School Heads

- 1. The Cebu Provincial Government is once again reaching out to the **top ten** graduating high school students of this Division to apply for the **Cebu Tertiary Education Assistance Program (CTEAP) for School Year 2013-2014.**
- 2. This program requires each applicant to submit the following:
 - a. Certification from the Principal that the aspirant belongs to the top 10 of the graduating students;
 - b. Certification of Good Standing from the Principal;
 - c. Barangay Clearance from the Barangay Captain;
 - d. Recommendation from the Mayor and/or from the Provincial Board Member of the District where the applicant comes from; and
 - e. ITR (Income Tax Return/Tax Exemption of Both Parents).
- 3. Relative thereto, the applicant shall agree to take up ladderized courses offered by State Universities and Colleges in Cebu, nearest their residence.
- 4. The parents of the scholar shall not have an income of over **One Hundred Twenty Thousand Pesos (Php 120,000.00)** per annum with certification from the Bureau of Internal Revenue or Municipal/City Treasurer.

- 5. The aspirant must pass a competitive examination and an interview by the Provincial Board (in coordination with the Provincial School Board) representing the particular district where he/she comes from.
- 6. Graduates from Public High Schools will be given top priority in this scholarship grant.
- 7. Successful applicants shall form a pool of scholars and will be given the following benefits:
 - a. Free tuition fee including miscellaneous expenses
 - b. Monthly allowance of Php 2,000.00
- 8. The competitive examination and interview shall be announced upon passing the prescreening to be handled by Mrs. Hermogena Miranda (1st Congressional District), Dr. Pamela Rodemio (2nd Congressional District), Mrs. Nenita Jaralve (3rd Congressional District), Mrs. Maria Elena Paras (4th Congressional District), Mrs. Glenna Plarisan (5th Congressional District), Dr. Mary Ann Flores (6th Congressional District) on April 15-19, 2013 at the Division Office Social Hall.
- 9. Deadline for the submission of documents for pre-screening shall be on April 12, 2013.
