1. The 2013 DepEd Election Task Force (ETF) Operation Center will be established in the *Bulwagan ng Karunungan*, Department of Education Central Office (DepEd CO), Meralco Avenue, Pasig City starting 1:00 p.m. of May 12, 2013 and ending on 12:00 noon of May 14, 2013.
2. The DepEd ETF will ensure that teachers shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of the Board of Election Inspectors (BEIs), as well as principals, supervisors, schools division/city superintendents and other employees of DepEd who will serve during the May 13, 2013 automated National and Local Elections.
3. The DepEd Election Task Force Operation Center shall also serve as DepEd's institutional link to volunteer organizations, individuals as well as partner agencies involved in the 2013 Automated National and Local Elections.
4. All DepEd officials and personnel, being in the civil service, are reminded not to intervene directly or indirectly, in any election campaign or engage in any partisan political activity, except to vote.
5. The list of management and administrative/operational staff relative to the preparation and actual operation of the DepEd ETF providing its composition is enclosed.
6. Immediate dissemination of this Memorandum is desired.
