**ADMINISTRATION OF THE 2013 PHILIPPINE EDUCATIONAL PLACEMENT TEST
(PEPT)**

1. Pursuant to DepEd Memorandum No.78, s. 2013, dated May 6, 2013, in commemoration of the 115th Celebration of Philippine Independence and consistent with the Education for All (EFA) goals, the Department of Education (DepED) through the National Education Testing and Research Center (NETRC) with the assistance of division and school personnel, shall administer the Philippine Educational Placement Test for free on June 12, 2013.

2. Registration shall start on May 8, 2013 and end on May 31, 2013 at the following testing centers :


3. The contact persons shall be in-charge with the evaluation of documentary requirements of each registrant and shall see to it that they are complete ,specifically Form 137 (Secondary) / Form138 (Elementary), birth certificate and two (1 x 1) pictures.

4. Using the data on school registration of out-of-school children and youth who are our primary target clientele, the PEPT will be administered to them to determine their grade/year level placement. Hence, they should be encouraged to avail of the learning modules prepared by the BALS, BEE and BSE or any other learning resources available at the region/division. These would enable them to upgrade their academic level for re-entry into formal school, job entry, job promotion and self-fulfillment.

5. School personnel who shall be assigned to administer the test shall be given one (1) day service credit as per DepED Order No. 53, s. 2003.

6. Expenses relative to the activity are chargeable against the NETRC funds subject to the usual accounting and auditing rules and regulations.

**ADMINISTRATION OF THE 2013 PHILIPPINE EDUCATIONAL
PLACEMENT TEST (PEPT)**

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools
All Others Concerned

1. In commemoration of the 115th Celebration of Philippine Independence Day and consistent with the Education for All (EFA) goals, the Department of Education (DepEd) through the National Education Testing and Research Center (NETRC) with the assistance of division and school personnel will administer the **2013 Philippine Educational Placement Test (PEPT)** for free on June 12, 2013 in all divisions nationwide.
2. Registration shall be at the division offices (DOs) until **May 31, 2013**. The Division Testing Coordinators (DTCs) are directed to submit the actual number of registrants to NETRC on or before **June 3, 2013**.
3. The DTCs shall be in-charge of the evaluation of documents and shall see to it that documentary requirements of each registrant are complete, specifically Form 137 (Secondary)/Form 138 (Elementary), birth certificate, and two (1x1) ID pictures.
4. Using the data on school registration of out-of-school children and youth who are the primary target clientele, the PEPT will be administered to them to determine their grade/year level placement. Hence, they will be encouraged to avail of learning modules prepared by the BALS, BEE and BSE or any other learning resources available at the region/division. The schools division/city superintendents (SDSs) are directed to ensure utilization of the test results by assisting them to re-enter the formal school in order to finish/complete the basic education program.
5. Authorized NETRC staff shall deliver and retrieve the test materials, and monitor the conduct of the test.
6. School personnel who shall be assigned to administer the test shall be given one day service credit as per DepEd Order No. 53, s. 2003.
7. The schools division/city superintendents (SDSs) shall identify the testing center/s for the test.
8. Immediate dissemination of this Memorandum is desired.
