**WHEREAS**, Monday, 13 May 2013 should be declared a special public (non-working) holiday to enable the people to properly exercise their right of suffrage.

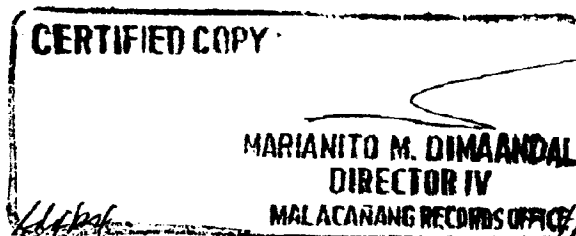
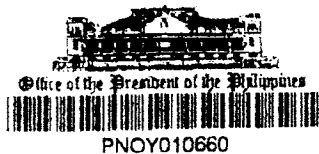

2. The 2013 DepED Regional Office Election Task Force Operation Center will be established in the DepED Regional Office (Administrative Division), Sudlon, Lahug, Cebu City starting 1:00 p.m. of May 12, 2013 and ending on 12:00 noon of May 14, 2013.
3. The DepED Regional Office Election Task Force will ensure that teachers shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of the Board of Election Inspectors (BEIs) as well as principals, supervisors, superintendents and other employees of DepED who will serve during the May 13, 2013 automated National and Local Elections. This will also serve as DepED's institutional link to volunteer organizations, individuals as well as partner agencies involved in the elections.
4. All Schools Division/City Superintendents (SDSs) are hereby directed to establish their Division Election Task Force. Submit the names of the members on or before May 7, 2013 c/o Miss Ida F. Cabantan, Admin. Division, tel. no. 414-7326; 414-7366, fax 2311-309, 414-7399. The Division Election Task Force is required to coordinate with the DepED Regional Office Election Task Force and submit a report of all the incidents/complaints regarding the conduct of the election.
5. Expenses for the establishment and operation of the Regional EFT and Division EFT shall be charged to Regional/Division Maintenance and Other Operating Expenses (MOOE), subject to the usual accounting and auditing rules and regulations.
