1. Quoted hereunder is Regional Memorandum No. 312 s. 2013, entitled, **“REGIONAL MASS TRAINING OF GRADE 2 PRIVATE SCHOOL TEACHERS IN THE IMPLEMENTATION OF K TO 12 BASIC EDUCATION CURRICULUM”**, to wit:

*“1. Pursuant to Republic Act No. 10533, s. 2013, **“AN ACT ENHANCING THE PHILIPPINE BASIC EDUCATION SYSTEM BY STRENGTHENING ITS CURRICULUM AND INCREASING THE NUMBER OF YEARS FOR BASIC EDUCATION, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES”**, this Office will conduct a Regional Mass Training of Grade 2 Private Schools Teachers in the Implementation of K to 12 Basic Education Curriculum (BEC) on June 3 – 7, 2013 at DepED ECOTECH Center, Sudlon, Lahug, Cebu City.”*

*“2. The training aims to:*

- a.) Provide teachers with a concrete understanding of the Grade 2 Curriculum Framework, Learning Standards and Competencies, Assessment and Teaching Plan; and*
- b.) Provide them with opportunities to acquire and demonstrate the values that will guide the teachers in the effective delivery of the curriculum and their roles as facilitators of learning.”*

*“3. Participants to this training are the **Grade 2 teachers from the Private Schools** in the 19 Schools Divisions of the Region. School Heads/School Principals/Directress is also encouraged to attend the said training.”*

*“4. A registration fee will be charged each participant to defray expenses for the 5-day training, particularly for board and lodging, venue, training materials, and honorarium of trainers, program management team, resource persons, and support staff. The following are the specifications:*
