1. Pantawid Pamilyang Pilipino Program (4Ps) is a human development program of the Department of Social Welfare and Development (DSWD) that invests in the health and education of poor households particularly with children aged 0-14 years old and aims to reduce poverty by providing qualified families of conditional cash grants as beneficiaries provided that they comply with the set of conditions required by the program.
2. Department of Education (DepED) as partner agency helps in monitoring the compliance of beneficiaries in terms of 85% attendance. It also provides the supply requirements of the program to be able to achieve its objectives in the aspect of education that DepEd provides. It includes teachers, classrooms, textbooks and other education facilities.
3. In support to the program, **each Schools Division Office shall submit a Consolidated Report of the 4Ps beneficiaries for SY 2012-2013 Baseline Report for both elementary and secondary levels.** The said report will be used to support DepED's budget proposal for school feeding of all severely wasted school children for SY 2014-2015.
