

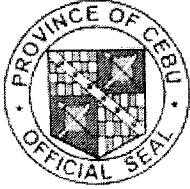

RESOLVED FURTHER, that a copy of this resolution be furnished to the Office of the Department of Education Region VII, for its information.


