**APPEAL FOR DONATIONS FOR DepED TEACHERS AND NON-TEACHING PERSONNEL  
AFFECTED BY THE ARMED CONFLICT IN ZAMBOANGA CITY AND BASILAN**



**TO : All Schools Division Superintendents  
Officers-in-Charge of Regular and Interim Divisions  
All Others Concerned**

1. The armed conflict between the Moro National Liberation Front (MNLF) and the military in Zamboanga City and Basilan has been going on for over a week as of this date. A large number of civilian personnel, including our teachers and non-teaching personnel, have been adversely affected by this conflict. Based on initial reports from the Division of Zamboanga City, there are two hundred forty-nine (249) DepED teachers and non-teaching personnel who have been displaced and staying in evacuation centers, sixty-four (64) of whom are fire victims as their residences have been burned in the armed conflict. We are continuously monitoring the situation in Zamboanga City and Basilan to determine how many of our teachers and non-teaching personnel are affected.
2. In this regard, we are once again appealing to your kind and generous hearts to extend a helping hand to our colleagues who have been gravely affected by this manmade calamity in Zamboanga City and Basilan.
