9th FOLKDANCE WORKSHOP FOR TEACHERS

- 1. The Department of Education (DepEd)- Division of Cebu Province announces the conduct of the Folkdance Workshop for Teachers on October 5-6, 2013 at Consolacion National High School, Covered Court, Consolacion, Cebu. The workshop days are Saturday and Sunday.
- 2. The workshop aims to enhance teachers' skills and competencies in teaching folkdances while increasing their stock knowledge of folkdances to be taught to pupils and students thereby capacitating them to effectively and efficiently contribute to the implementation of the cultural development program of this Division.
- 3. The workshop will consist of learning newly researched folkdances as well as classic Philippine folkdances and lectures on dance production and folkdance staging.
- 4. An unpublished folkdance from the Division of Cebu Province shall be taught during the workshop which shall be the official contest piece in the Cultural Festival in the upcoming 2013 Provincial Meet.
- 5. Participants to the workshop are elementary and secondary teachers in the public and private schools and folkdance enthusiasts. Participants should be physically fit to undergo strenuous activities. No pregnant participant shall be allowed.
- 6. This Memorandum shall serve as Authority to Travel for the participants.
- A registration fee of Php 300.00 shall be charged each participant to defray expenses for handouts, and dance literature, CD's to contain the music of the dances taught, certificates, honoraria of resource persons and other operating expenses necessary for the conduct of the workshop. Registration, transportation and other expenses incurred by the participants from the public schools on account of their participation in the workshop shall be chargeable against local school/MOOE/SEF/PTA or any fund subject to their availability and the usual accounting and auditing rules and guidelines. Participants from the private schools can make arrangements with the administration of their respective schools on matters relative to participation expenses.
- 8. Participants are to come to the workshop in PE or any comfortable attire and rubber/flat shoes. However, norms of decency appropriate for educators should be observed by workshop participants in their choice of comfortable attire (i.e. no short pants, spaghetti strapped or tube blouses and the like shall be allowed).

9. Immediate and wide dissemination of this Memorandum is desired.
