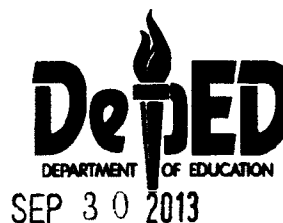

The First place winners from both the public and private high school categories will represent DepEd Region VII in the National Finals to be held on **October 16, 2013** at **Tanghalang Yaman Lahi, Emilio Aguinaldo College Auditorium, Ermita, Manila**. They are advised to report to the venue two days before the actual contest for orientation, stage blocking and pictorial purposes. Further, they are required to wear their school uniforms during the contest.

Expenses incurred for the transportation, accommodation and other incidental expenses of the Regional representative, coach, and Education Supervisors who will accompany the contestant from the public school may be charged to Local/Division MOOE funds or SEF funds, subject to the usual accounting and auditing procedures, while expenses of the Regional representative and coach from the private school shall be arranged by the school administration.
