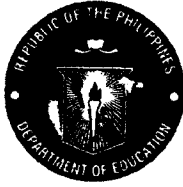

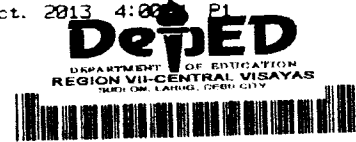

Greetings.

The Professional Regulatory Board (PRB) of the Guidance and Counseling Profession has commissioned the Philippine Guidance and Counseling Association (PGCA), to train and capacitate registered guidance counselors on being ready to respond and give psychosocial support to survivors during disasters and calamities. For the purpose, PGCA has designed a module on "Psychosocial Support for Survivors of Disasters and Calamities" and has scheduled a seminar workshop for its use to the different PGCA local chapters.
