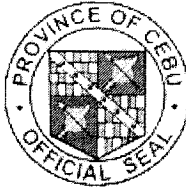

**URGING SCHOOL ADMINISTRATORS THROUGHOUT THE PROVINCE OF CEBU TO BE MORE VIGILANT AND ENSURE THAT PRODUCTS SOLD WITHIN SCHOOL PREMISES ARE FDA REGISTERED. -**

**WHEREAS**, Sec. 16 of the Local Government Code provides that “Every Local Government Unit shall xxx promote (the) health and safety xxx of its inhabitants;

**WHEREAS**, Republic Act No. 3720 and 9711 mandates the Food and Drugs Administration “to ensure the safety and purity of foods, drugs and cosmetics being made available to the public xxx”;

**WHEREAS**, recently the Food and Drugs Administration acted on a report about a certain vitamin syrup being peddled in the school premises wherein such vitamin syrup was unregistered with the FDA;

**WHEREAS**, it is alarming to know that products without the approval of the FDA are being sold freely within school premises which may place the health of the children at risk;

**WHEREAS**, this august Body strongly urges school Administrators throughout the Province of Cebu to exercise extreme vigilance making sure that products sold within their school premises are safe and are registered with the FDA to safeguard the health of their students;

**NOW, THEREFORE**, on motion of Majority Floor Leader/Author, **Hon. ARLEIGH JAY C. SITOY**, duly seconded by Presiding Officer Pro Tempore, **Hon. JULIAN B. DAAN**, be it

**RESOLVED**, as it is hereby **RESOLVED**, to urge school Administrators throughout the Province of Cebu to be more vigilant and ensure that products sold within school premises are FDA registered;

**RESOLVED FURTHER**, that copies of this resolution be furnished to all School Administrators, for their information and appropriate action.
