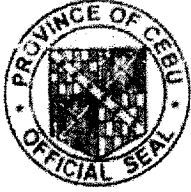

RESOLUTION NO. 1030-2013

AUTHOR : HON. THADEO Z. OUANO

REQUESTING ALL LOCAL GOVERNMENT UNITS (LGUS) IN THE PROVINCE OF CEBU TO CONDUCT ACTIVITIES SUPPORTING WATER CONSERVATION AND TO JOIN THE PROVINCE OF CEBU TOGETHER WITH OTHER AGENCIES AND NON-GOVERNMENTAL ORGANIZATIONS (NGOs) IN ITS CELEBRATION OF "WATER CONSERVATION MONTH" IN SEPTEMBER.

WHEREAS, water is considered as the lifeline of most human, social and economic activities while clean and sustainable water resources and supplies are vital to the economy, environment and citizens of the country including that of the Province of Cebu;

WHEREAS, the country's water resources continue to decline in quality and abate quantity which tells us the great probability of water shortage supply in the future which reminds us that water resources and supplies, no matter how diverse, are finite;

WHEREAS, all water users including agricultural, industrial, hospitals and other commercial, institutional and private citizens can contribute to conserving Cebu Province's dwindling water resources and each stakeholders can actively participate in the protection of water resources by promoting the efficient use of water and advocating sound water conservation practices;

WHEREAS, sound water resource management and water supply development can be best achieved by consensus building, establishing broad educational networks and partnerships, conducting water use efficiency research, implementing appropriate best management practices, and sharing data to foster development of local and provincial water conservation policies;

WHEREAS, due to this compelling necessity to conserve water, former SP Member Victor A. Maambong authored Ordinance No. 2003-12, declaring every Month of September as Water Conservation Month for the Province of Cebu, which will be celebrated with a variety of activities aimed at promoting protection, conservation, rehabilitation and management of Cebu's water resources;

WHEREAS, during Water Conservation Month, the conduct of information and education campaigns on water conservation measures and the efficient utilization of water is encouraged especially at grassroots level to be spearheaded by the Local Government Units (LGUs), Department of Environment and Natural Resources (DENR), Department of Interior and Local Government (DILG), Philippine National Police – Police Regional Office 7 (PNP-PRO 7), Department of Education (DepEd), Department of Agriculture (DA), Department of Health (DOH), Bureau of Fisheries and Aquatic Resources (BFAR) and the Province of Cebu;

NOW, THEREFORE, on motion of Acting Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Presiding Officer Pro Tempore, **Hon. JULIAN B. DAAN**, for the approval of the resolution authored by Member, **Hon. THADEO Z. OUANO**, be it

RESOLVED, as it is hereby **RESOLVED**, to request all Local Government Units (LGUs) in the Province of Cebu to conduct activities supporting water conservation and to join the Province of Cebu together with other agencies and Non-Governmental Organizations (NGOs) in its celebration of the "Water Conservation Month" in September;

RESOLVED FURTHER, that copies of this resolution be furnished to Governor Hilario P. Davide III, all LGUs of the Province of Cebu, DENR, DILG, PNP-PRO 7, DepEd, DA, DOH and BFAR, for their information and appropriate action.
