In support to and consistent with the provisions of Republic Act No. 9994 or "The Expanded Senior Citizens Act" and Batas Pambansa Bilang 344, otherwise known as the "Accessibility Law", all concerned providing frontline services in the Department are hereby directed to put up "Priority Lanes" for Senior Citizens (SCs) and Persons with Disabilities (PWDs) in your respective Offices. Such lanes shall preferably be situated near the entrance and free from any physical barriers.
