1. The Department of Education-Cebu Province Division is soliciting sealed proposals from

- 3. Proposal through emails will be automatically disqualified.
- 4. Upon receipt of at least three (3) proposals, the BAC shall have the option to open the proposals on or before the submission deadline.

1. The service provider shall be able to furnish seven (7) digital copying machines free of charge to the following sections:

2. The service provider shall waive any form of billing for the delivery, services and maintenance of the aforementioned copying machines and in consideration of such arrangement, this Division shall only purchase the consumable components (Ex. Drum Kit with Blade, Fixing Film and Toner (500g) from the concerned service provider. The cost of the consumable components shall be at par or lesser than the prices of the consumable components of the same specifications available in the market. Replacement of parts due to misuse or abuse shall be shouldered by the Division.

- 4. The service provider shall remain the absolute owner of the aforementioned equipments.
- 5. In order to determine if the service providers are technically, legally and financially capable, proposals should include: 1) specifications of machines you are proposing, 2) estimate of monthly cost of the consumable components (ex. Drum kit with blade, fixing film and toner), per machine, 3) maintenance schedule 4) Latest Income and Business Tax Returns or PhilGEPS Registration, 5) current Mayor's Permit issued by the City or Municipality where the principal's place of business is located; and 6) one (1) copy of this Request for Proposal. Proposals with incomplete documents shall be immediately disqualified.
- 6. The service provider with the most advantageous terms to DepEd Cebu Province as evaluated by the Bids and Awards Committee (BAC) shall execute a Memorandum of Agreement with the Head of the soliciting agency. The MOA shall be in effect for one year reckoned from the date of MOA signing, unless sooner terminated for justifiable cause.
