- In support to MTB-MLE Certificate Program of the Ramon Aboitiz Foundation Incorporated (RAFI) in coordination with the University of San Jose-Recoletos College of Education and DepED Region VII, the scholars are required to comply with the requirements for graduation in May 2014.
