AS OF 2012 FOR SY 2014-2015**

1. Attach herewith is, Unnumbered Memorandum signed by DepEd Secretary, Br. Armin A. Luistro FSC, dated, March 20, 2014, reminding the field regarding the following policies of the Department relative to hiring of Teacher-1, to wit:

A. Only qualified kindergarten volunteer teachers and LGU-hired teachers as of 2012 may be hired and regularized for SY 2014-2015, subject to the present hiring guidelines of the Department.

B. Discontinuance in the hiring of new LGU-funded and kindergarten volunteer teachers starting SY 2014-2015.

C. Approval from the Central Office is required in exceptional cases where there is a justifiable need to hire LGU-funded and kindergarten volunteer teachers. The request should be sent on or before April 25, 2014.

2. Immediate dissemination of this Memorandum is desired.



SUBJECT : Discontinuation of the Hiring of LGU-funded and Kindergarten Volunteer Teachers and Reminder to Hire Only Qualified LGU-funded and DepEd-subsidized Teachers as of 2012 for SY 2014-2015

In our ardent desire to provide quality basic education, the Department continuously endeavors to address the perennial problem of teacher shortages in all public schools nationwide. Since SY 2010-2011, an unprecedented total of 102,623 new teaching positions (kindergarten, elementary and secondary) have been created. To provide opportunities for the regularization and absorption of all qualified kindergarten volunteer teachers and LGU-hired teachers into the national plantilla, the Department created 61,510 teacher items in 2013. For SY 2014-2015, an additional 33,194 new kindergarten, elementary, and secondary Teacher I items have been created to ensure that the regularization and absorption of the remaining qualified kindergarten volunteers and LGU-hired teachers.

For this reason, you are reminded that **only qualified kindergarten volunteer teachers and LGU-hired teachers as of 2012** may be hired and regularized for SY 2014-2015. Needless to say, all appointments made must be in strict accordance with our present hiring policy.

In this connection, you are enjoined to **discontinue the hiring of new LGU-funded and kindergarten volunteer teachers starting SY 2014-2015**. In exceptional circumstances where a justifiable need to do otherwise exists, you are instructed to seek prior approval from the Central Office by sending a cover letter containing the relevant documentations for evaluation. The communication should be sent to this Office, attention to the Office of Assistant Secretary Jesus L.R Mateo, on or before **April 25, 2014**.

Any violation of this directive will be dealt with accordingly.
