**Guidelines for the 2014 NATIONAL COMPETITION FOR ALS LEARNING FACILITATORS
ON THE DEVELOPMENT OF BASIC LITERACY LEARNING MATERIALS**

I. Background

The ALS Teacher Program of the Bureau of Alternative Learning System supports the professional growth and competency development of ALS Learning Facilitators.

In 2006, there was a national module writing competition for ALS Mobile Teachers wherein the winning modules formed part of the basic literacy learning materials currently used nationwide. In 2007, BALS conducted a successful National Competition on ALS Supplementary Learning Materials Development that ALS Mobile Teachers participated in.

This year, BALS launches the 2014 National Competition for ALS Learning Facilitators on the Development of Basic Literacy Learning Materials, particularly involving the District ALS Coordinators (DALSCs), Mobile Teachers (MTs), Instructional Managers (IMs) and Literacy Volunteers (LVs) nationwide.

II. Objectives

The national competition aims to develop/enhance the knowledge and skills of ALS Learning Facilitators through the development of quality, innovative and appropriate **basic-level modules/materials**; produce additional modules for basic-level learners in different formats in compliance with the K to 12 Curriculum; and recognize/encourage interests, strengths, and talents of the Learning Facilitators on the development of learning materials.

III. General Guidelines

1. The competition is open to all DALSCs, MTs, IMs and LVs nationwide.
2. The competition will be conducted at the national level. However, only entries that will be nominated and endorsed by the DepEd Regional Office will be included in the national evaluation.
3. The competition will be in two formats: Print and Non-print Learning Materials.
4. Each region is entitled to submit best five (5) entries per category:
5. Entries must be based on the learning competencies in the ALS Curriculum for basic literacy level and the K to 12 Curriculum.
6. Regional entries will be submitted in three copies.
7. Submission of an entry must be accompanied by a duly accomplished Entry Form (Enclosure 2).
8. All entries endorsed by the DepEd Regional Director must be submitted and addressed to:

9. Receipt of entries may be confirmed with the Literacy Division, BALS at telephone number (02) 6354694 (direct line), (02) 6355189 (fax).
10. All national entries become property of DepEd.
11. **Deadline for submission is on July 4, 2014.** All entries must reach the BALS on or before this date.

IV. Major Considerations in the Module Writing

1. The entries for the competition are categorized as follows:
 - 1.1 Print Learning Materials
 - ALS Basic Literacy Learning Material/Module
 - 1.2 Non-print Learning Materials
 - ALS Digitized Learning Module
 - ALS Radio-based Instruction Lesson/Script
2. Print Learning Materials
 - 2.1 **ALS Basic Literacy Learning Materials/Module.** It must be accompanied by Session Guide to demonstrate the use in the learning session for Basic Literacy. Please see Enclosure 3 for the Session Guide template.
3. Non-print Learning Materials
 - 3.1 **ALS Digitized Learning Module.** It must be accompanied by a Storyboard, Script, and Module Guide. The Module Guide (eGuide) should not be more than 3 pages, written on a letter/short-sized bond paper, double-spaced. The cover page should contain vital information about the learning material and the author. It must contain basic information on the following:
 - 3.1.1 Description of the digitized learning module/material
 - What are the objectives? Determine what you want to accomplish.
 - Who are the target audience? The group of people you want to reach
 - Why is it recommendable? State the use, benefits, advantages, and limitations of the learning material.
 - 3.1.2 Utilization of the digitized learning module/material
 - How to use the digitized learning module/material. Step-by-step description on the utilization of the material.
 - 3.2 **ALS Radio-based Instruction Lesson/Script.** It must be accompanied by a Session Guide and Canned Lessons (audio lesson).
4. All learning materials and session/module guides must be based on experiential/adult learning approach or the 4As of learning (activity, analysis, abstraction, and application).
8. All participating ALS Learning Facilitators are encouraged to exercise creativity in developing the learning materials.
9. Entries must be produced in Filipino language.

V. Evaluation of Entries

1. Regional offices may create their own selection strategy using their own resources to obtain regional entries.
2. All entries nominated by the DepEd Regional Director will undergo evaluation and judging at the national level.
3. There will be separate evaluations for all categories namely, Print: a) ALS Basic Literacy Learning Material/Module, and Non-Print: a) ALS Digitized Learning Module; b) ALS Radio-based Instruction Lesson/Script.
4. Evaluation and judging at the national level will involve a panel of external evaluators and selected BALS technical staff who will evaluate the regional entries to determine the national winners.
5. The decision of the Panel of Evaluators is final and irrevocable.
6. Any entry found to be copied or imitated will be subjected to immediate disqualification and administrative sanction.
7. The winners and the schedule of awarding will be announced formally.

VI. Criteria for Evaluation

The competition entries will be evaluated based on the following criteria:
