

- In line with the thrust of the Department of Education (DepEd) to create a conducive learning and teaching environment for elementary pupils and secondary students, this Department shall provide basic educational facilities to public schools nationwide from its General Appropriations.
- Appropriations amounting to P 15.11 Billion and P 37.7 Billion were allotted for the construction and repair of 35,000 classrooms and 43,183 classrooms in Fiscal Year (FY) 2013 and FY 2014, respectively.
- The FY 2013 and FY 2014 allocations per school shall be provided by the Physical Facilities and Schools Engineering Division (PFSED) of the Office of Planning Service (OPS) through the Regional Planning Unit (RPU). These allocations shall be posted in the official DepEd website: www.deped.gov.ph. Schools Division Offices (SDOs) shall post this document containing the allocations in the bulletin board and shall disseminate to all schools.
- Using the format provided in the enclosure, school heads (SHs), teachers-incharge (TICs), or school principals/coordinators shall confirm receipt of the FY 2013 and FY 2014 classroom allocations and shall regularly submit status reports to the SDO including all proposals from various stakeholders relative to the construction, repair, and/or rehabilitation of classrooms.
- To ensure the effective and efficient implementation of the classroom construction program, a composite team under the supervision of the OPS shall conduct an evaluation in accordance with the program implementation plan.
