As of June 16, 2014, we have already mapped 1,248,824, spread throughout the three tracks provided for them: education, entrepreneurship, and employment.

In order for us to have a national database of all OSYs mapped, we would like to request the regional offices to submit the list of names of the OSYs mapped, along with the other information included in the Abot-Alam Data Gathering Form. Currently, it is the National Youth Commission (NYC) that maintains the database for Abot-Alam.
