First meal will be Dinner of Day 1 and last meal will be afternoon snacks of Day 3.

This Office invites the participation of the talent groups from Mandaue City School for the Arts and Don Vicente Rama MNHS School for the Arts, Cebu City Division to perform significant parts in the Opening Program, ie., Doxology, Philippine National Anthem and two (2) intermission numbers. Meals will be provided for all the participants/nominees, CO/RO staff, guest performers and teacher-coaches.
4. Expenses such as food & accommodation shall be charged to the Central Office Funds while travel expenses for the 8 shortlisted student-nominees, guest performers and teachers are chargeable against Local funds/School MOOE/SEF/PTCA funds, all subject to the usual accounting and auditing rules and regulations.

**DATE: 6 August 2014**

On January 18, 2013, Prime Minister Shinzo Abe, during his visit in Indonesia, announced to undertake a new youth exchange programme between Japan and ASEAN Member States called "JENESYS 2.0" (Japan-East Asia Network of Exchange for Students and Youth). It aims towards the revitalization of the Japanese economy, increasing visitors to Japan, and at the same time, promoting global understanding on Japanese values. Approximately 30,000 youth from the Asian/Oceanian region will have an opportunity to participate in the programme.

In partnership with the Japan International Cooperation Center (JICE), the implementing agency of JENESYS 2.0, the Department of Education will be sending its second and third batches of students to Japan on November 2014 and January 2015.

In this light, we would like to reiterate the dates of screening per island bloc.

- **August 22-24, 2014 – Luzon-wide Screening**, Teacher's Camp, Baguio City. Check-in is at 3:00PM and first meal is at 6:00PM on August 22, 2014. Opening Program and Interviews is on August 23 – 24.
- **August 27-29, 2014 – Visayas-wide Screening**, DepEd Ecotech, Cebu City. Check-in is at 3:00PM and first meal is at 6:00PM on August 27, 2014. Opening Program and Interviews is on August 28-29.
- **September 1-3, 2014 – Mindanao-wide Screening**, DepEd RELC, Cagayan de Oro City. Check-in is at 3:00PM and first meal is at 6:00PM on September 1, 2014. Opening Program and Interviews in on September 2, 2014.

Expenses such as food, accommodation, and travel expenses for the 8 shortlisted student nominees of each region and 1 supervisor who are going to the final interviews and screening shall be charged against local funds, all subject to the usual accounting and auditing rules and regulations.
