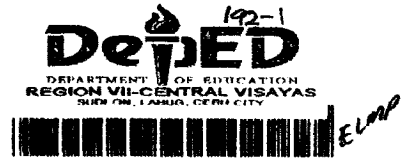

2. The activity aims to strengthen the accountability of stakeholders through the leadership of school heads in the Governance of Basic Education towards the realization of Education for All (EFA).
