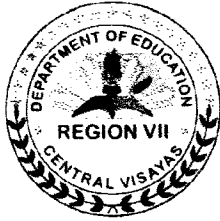

**CVIRAA'S NON-INCLUSION OF WRESTLING IN THE 2015 PALARONG PAMBANSA**

To: All Schools Division Superintendents

1. During the 2015 CVIRAA Meet, wrestling was included as one of the sports events played as a demo sport. However, the management officials received negative feedback particularly on the health and safety of the student wrestlers. They concluded that wrestling is not advisable to be played by our students.
2. In view hereof, it is hereby announced that the Central Visayas Regional Athletic Association (CVIRAA) will not include wrestling during the 2015 Palarong Pambansa.
3. All concerned Divisions which have training for wrestling are advised to **discontinue their training program**.
