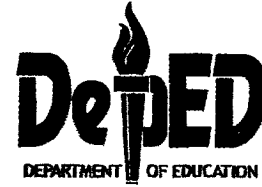

In view of the DepED Order No. 7, s. 2015, entitled "*Hiring Guidelines For Teacher I Positions Effective School Year 2015-2016*", that all applicants shall register to the Department's online system, please be informed of the following :

- 1) Instruction from Assistant Secretary Jesus L.R. Mateo, DepED Central Office, that all applications of teacher-applicants shall be accepted and processed even without Tax Identification Number (TIN).
- 2) Advised teacher-applicants/applicants without Tax Identification Number (TIN) can register online starting Wednesday, April 8, 2015 and be ready with any of the following IDs : Voter's ID, Passport Number, SSS Number, GSIS Number (or UMID Card Number), Postal ID or PhilHealth ID.
- 3) Teacher-applicants/applicants are advised to visit and be updated through DepED Online Application System Frequently Asked Questions (FAQs).
