SUBMISSION OF RPMS RATING FOR SY 2014-2015 and THE NEW PERFORMANCE EVALUATION CYCLE

District Supervisors/OICs
Elementary and Secondary School Heads

- 1. This Office announces the deadline of submission of final teachers consolidated RPMS Rating for school year 2014-2015, this coming May 11, 2015, using the herein attached format.
- 2. In addition, the field is hereby informed of the new performance evaluation cyle which starts this month of April 2015 and will end this coming March 2016, for the School-based personnel. The School-based Personnel include all regular/permanent, LGU -funded and contract of service/job order teaching, teaching related and non-teaching personnel assigned and/or detailed in the schools including mobile teachers. However, the evaluation cycle for the Non School-based Personnel started last January 2015 and will end this coming December 2015. The Non School-based Personnel include all regular/permanent, LGU funded and contract of service/job order personnel assigned and/or detailed in DepEd Offices, from Central Office to the Schools Division Offices, as provided under DepEd Order No. 2, s. 2015.
- 3. Relative to that, all Area Consultants, District Supervisors and HR Officer are directed to monitor. supervise and provide technical assistance in the implementation of the Four-stages of performance management system cycle, as prescribed by the CSC:
 - i. Performance planning and commitment (Phase I);
 - ii. Performance monitoring and coaching (Phase II);
 - iii. Performance review and evaluation (Phase III); and
 - iv. Performance rewarding and development planning (Phase IV).
- 4. Immediate dissemination of and strict compliance with this Memorandum is directed.
