LAUNCHING THE THIRD TEACHERS' AND EMPLOYEES' REGIONAL INTER-DIVISION/DISTRICT BASKETBALL TOURNAMENT AND START OF THE VOLLEYBALL TOURNAMENT

To : Schools Division / City Superintendents

1. To continue the fitness program for all DepED Teachers and Employees, *in coordination with the Lapu-Lapu City Central Teachers Cooperative*, the Third Teachers' and Employees' Regional Inter-Division/District *Basketball* Tournament (2 age-level categories) and Start of the *Volleyball* Tournament (men & women open-age categories) shall be launched on June 27, 2015 8:00 AM at Lapu-Lapu City Basketball Gym. It will start with the Registration, to be followed with a simple parade, short program and 3 games per event of the tournament. Each Team shall be responsible of their own necessary provisions.
2. FIBA and FIVB Rules shall be followed respectively. However, the Committee can modify the rules as the need arises. The Committee's decision is, at all times, final.
3. During Registration, the team shall :
 - be in complete line-up wearing the tournament uniform.
 - bring all requirements (Employment & Medical Cert., DepED I.D.-photocopy and waiver).
 - pay an initial Registration Fee of PhP 2,000.00.
 - attend the Refresher Course and sign the Tournament Ground Rules.Early registrants will be accepted through the above-mentioned cooperative.
4. The registration fee, uniform and other incidental expenses relative to these activities shall be from personal/stakeholders funds or may be charged against Region/Division MOOE/SEF, PTA and/or other funds subject to the usual accounting and auditing rules and regulations.
