URGING ALL PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF CEBU TO REGULARLY CHECK FOOD CONCESSIONAIRES WHO OPERATE INSIDE AND OUTSIDE THEIR SCHOOL PREMISES TO PREVENT FOOD POISONING.

WHEREAS, contamination of food can happen at any point during its production, storage and preparation;

WHEREAS, it is observed that some foods that are sold outside school premises are prone to bacteria and contaminants from vehicle emissions;

WHEREAS, the general welfare clause of the Local Government Code, mandates local government units to ensure the protection and promotion of the health and safety of their inhabitants;

WHEREAS, it is, therefore appropriate to have a regular check on food concessionaires who operate inside and outside their school premises to avoid and prevent the occurrence of the food poisoning;
