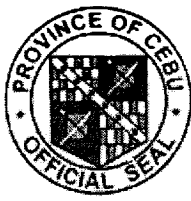

**URGING ALL PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF CEBU TO REGULARLY CHECK FOOD CONCESSIONAIRES WHO OPERATE INSIDE AND OUTSIDE THEIR SCHOOL PREMISES TO PREVENT FOOD POISONING.**

**WHEREAS,** contamination of food can happen at any point during its production, storage and preparation;

**WHEREAS,** it is observed that some foods that are sold outside school premises are prone to bacteria and contaminants from vehicle emissions;

**WHEREAS,** the general welfare clause of the Local Government Code, mandates local government units to ensure the protection and promotion of the health and safety of their inhabitants;

**WHEREAS,** it is, therefore appropriate to have a regular check on food concessionaires who operate inside and outside their school premises to avoid and prevent the occurrence of the food poisoning;
