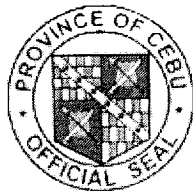

STRONGLY URGING ALL PRIVATE SCHOOLS AND UNIVERSITIES IN THE PROVINCE OF CEBU TO CONDUCT THEIR OWN RANDOM DRUG TESTING OPERATIONS TO ALL THEIR TEACHERS AND EMPLOYEES.

WHEREAS, recently, two teachers were apprehended by the authorities for alleged drug use;

WHEREAS, it is but an alarming fact that some educators who were supposedly entrusted with the student's welfare and should serve as an example of morality that would teach them valuable life's lessons are the same ones misleading them;

WHEREAS, such is a great concern to the Province considering that should we lay a blind eye or tolerate such actions, we are placing our future generations at stake;

WHEREAS, the Province of Cebu through the Cebu Provincial Anti-Drug Abuse Commission (CPADAC) has requested the Department of Education Region VII to issue a memorandum that would enjoin public school teachers to submit themselves to random drug testing;

WHEREAS, in the preservation of the welfare of our students as well as the future of the Province, this august Body finds it necessary to strongly urge all Private schools and Universities in the Province of Cebu to conduct their own random drug testing operations;

WHEREAS, the Local Government Code of 1991 enjoined LGUs to promote health and safety, improve public morals, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW, THEREFORE, on motion of Majority Floor Leader/Author, Hon. ARLEIGH JAY C. SITOY, duly seconded by Presiding Officer Pro Tempore, Hon. JULIAN B. DAAN, be it

RESOLVED as it is hereby RESOLVED, to strongly urge all private schools and universities in the Province of Cebu to conduct their own random drug testing operations to all their teachers and employees.


