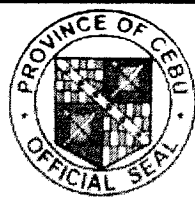

REQUESTING ALL LOCAL GOVERNMENT UNITS IN THE PROVINCE OF CEBU AND THE DEPARTMENT OF EDUCATION (DepEd), CEBU TO IDENTIFY AND SUBMIT THE NAMES OR CREATE A DATABASE OF POSSIBLE CANDIDATES FOR PHASE ONE OF THE THREE-PHASE CONTINUOUS ACTION MODEL OF STARKEY HEARING FOUNDATION TO THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE ON OR BEFORE JUNE 11, 2015.

WHEREAS, the Starkey Hearing Foundation is a US based foundation dedicated to providing the gift of hearing to hearing impaired individuals all around the world;

WHEREAS, this decade, they are aimed at providing One Million Hearing Aids once more after reaching their One Million target last 2010;

WHEREAS, said foundation utilizes a three-phase continuous action model, Phase one is where they identify, screen and provide primary ear-care services to potential hearing aid candidates as well as take ear impressions and create custom earmolds for individuals whom they find are in need of hearing aids;

WHEREAS, Phase one of their three-phase model will take place on June 22, 2015 and by such time, it is advisable that we take advantage of such opportunity to help our constituents who have hearing impairments and help them live normal lives;

WHEREAS, not only will they provide hearing aids (Phase 2) with custom earmolds but they will also be providing a year supply of batteries as well as a continuous after-care program (Phase 3) that will include recounseling, batteries and free services to repair or replace hearing aids when needed;

WHEREAS, such program is an opportunity worth grabbing, thus, premises considered, this august Body hereby requests all Local Government Units in the Province of Cebu and DepEd, Cebu to identify and submit names of possible candidates for phase one of the Starkey Hearing Foundation continuous action model;

WHEREAS, Section 16 of the Local Government Code of the Philippines enjoins all LGUs in the Province of Cebu to promote health and safety as well as preserve the comfort and convenience of their inhabitants;

NOW, THEREFORE, on motion of Majority Floor Leader/Author, Hon. ARLEIGH JAY C. SITOY, duly seconded by Presiding Officer Pro Tempore, Hon. JULIAN B. DAAN, be it

RESOLVED as it is hereby RESOLVED, to request all Local Government Units in the Province of Cebu and the Department of Education (DepEd), Cebu to identify and submit the names or create a database of possible candidates for Phase one of the three-phase continuous action model of Starkey Hearing Foundation to the Provincial Social Welfare and Development Office on or before June 11, 2015.
