1. Consistent with the Department's initiated advocacy programs to balance physical fitness and good nutrition which is essential in the development stage of our learners, DepEd Region VII in partnership with Nestle Philippines, Inc. and Greatfil Team, Inc. will jointly implement the program entitled "Wellness Campus".
2. In implementing this program, a Memorandum of Understanding between DepEd Region VII, Nestle Philippines, Inc. and Greatfil Team, Inc. has been signed. The Wellness Campus is designed to be implemented in all Schools Divisions in the region especially the public secondary schools. The program aims to help the high school students adopt a lifestyle of wellness and fully aware of good nutrition and physical fitness.
3. To ensure success in this endeavor, all Division PESS/MAPEH Supervisors/Coordinators, and Division Health personnel are requested to coordinate with one another. The Division PESS/MAPEH Supervisors/Coordinators will monitor the fitness exercises in the schools and at the same time take charge in the distribution and retrieval of the Nutrition Assessment Forms and the distribution of book marks. The Division Health personnel will monitor the inclusion of proper nutrition in subject areas as specified in the modules to be distributed.
4. In line with this year's Nutrition Month Celebration, a formal launching and orientation meeting of the program will be held this coming July 8, 2015 at 10:00 in the morning, Laguna Garden Cafe, Ayala Terraces, Ayala Center, Cebu City.
5. Participants to the launching and orientation meeting are the Regional ESSD Staff, Schools Division Superintendents and the Division PESS/MAPEH Supervisors/Coordinators.
6. Expenses incurred in the launching will be shouldered by the organizers (Nestle Phil., Inc. and Greatfil, Inc.), while travel expenses of the participants shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
