## **RESOLUTION NO. 1390-2015**

**AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE** 

URGING ALL PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF CEBU TO UNDERTAKE TREE PLANTING ACTIVITIES AND PROVIDE EFFECTIVE MEASURES FOR ITS MAINTENANCE AND SUSTAINABILITY IN OBSERVANCE OF THE PHILIPPINE ARBOR DAY.

WHEREAS, in Sec. 2 of RA 10176, it is declared the policy of the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature, role and importance of trees in ecological stability is recognized;

WHEREAS, Proclamation No. 643 sees the necessity to promote a healthier ecosystem for the people through the rehabilitation and re-greening of the environment, which enjoined the active participation of all government agencies, including government-owned and controlled corporations, private sector, schools, civil society groups and the citizenry in tree planting activity;

WHEREAS, the Cebu Provincial Government sees the need for a collaborated effort among its citizenry to combat the loss of our natural resources and rejuvenate our environment by undertaking tree planting activities and providing effective measures for its maintenance and sustainability; and the need to highlight the celebration of ARBOR DAY in the Province;

WHEREAS, with the recent opening of classes, and June being the environment month, it is the right time to strengthen and promote environmental awareness specially amongst students, and employ strategic measures that will ensure active participation of all public and private schools in tree planting activities;

NOW, THEREFORE, on motion of Majority Floor Leader, Hon. ARLEIGH JAY C. SITOY, duly seconded by Presiding Officer Pro Tempore, Hon. JULIAN B. DAAN for the approval of the resolution authored by Member, Hon. MIGUEL ANTONIO A. MAGPALE, be it
