2. Qualified applicants to take the test are Filipino Citizens who are/have:

- Drop – outs (Out of School) from elementary/secondary school for at least one (1) year.
- Overage in – school children/youth at least one (1) year of their actual grade level.

- Never attended a formal school but can read and write.
 - Presently employed and in need of upgrading their academic level (elementary/secondary) for re - entry into formal school, job entry, job promotion and self – fulfillment.
3. Applicants are required to submit the following documents, namely:
- 3.1. Birth Certificate (NSO or Local Civil Registration – Original and two (2) Photocopies)
 - 3.2. ID Pictures – 2 pieces, identical and recently taken, size 1"x1"
 - 3.3. School Records – Original and two (2) Photocopies
 - Elementary level: Form 137 or Form 138
 - Secondary Level: Form 137
 - 3.4. School Permit - Photocopy of School Permit to Operate/Government Recognition (for applicants from private schools)
 - 3.5. Registration Fee (Non-Refundable) – PhP 50.00
4. Qualified applicants are encouraged to register and submit their documents/credentials at the testing center near their home/residence.
