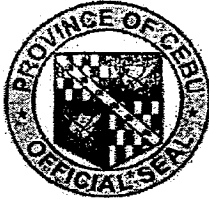

ENCOURAGING THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) AND THE DEPARTMENT OF EDUCATION (DepEd) TO INITIATE IN SELECTED PUBLIC SCHOOLS THE INCLUSION OF ROBOTICS AS A COMPLEMENTARY COURSE THAT PUBLIC SCHOOL STUDENTS MAY AVAIL OF.

WHEREAS, the 1987 Constitution declares that Science and Technology are essential for National development and progress in which the State shall give priority to Research and Development, Invention, Innovation and their utilization and to Science and Technology Education, Training and Services;

WHEREAS, the rise of Robotics have indicated growing popularity among Students and

WHEREAS, however, the Province of Cebu recognizes that to avail for such opportunity may prove to be elusive for some school children in the Province, taking cognizance of the costs that may entail in providing such to Public Schools;

WHEREAS, despite this resource limitations, this august Body believes that giving opportunity for Students to learn is of paramount importance and that agencies of the Government must strive hard to ensure that opportunities for interested children to learn Robotics are available to the widest extent possible;

RESOLVED, as it is hereby **RESOLVED**, to encourage the Department of Science and Technology (DOST) and the Department of Education (DepEd) to initiate in selected Public Schools the inclusion of Robotics as a complementary course that Public School Students may avail of.
