1. The field is hereby informed that the English Proficiency Test (EPT) for Teacher-1 applicants in the Elementary, Junior and Senior High School is scheduled on April 2, 2016 (Saturday), at Minglanilla Central School, Minglanilla District I, Cebu.
2. **Applicants who have taken the English Proficiency Test last school year 2015 – 2016 are no longer required to take the test. The test result of last year is still valid for this year's recruitment.**
3. Examinees are advised to bring the following on the day of the examination:
  - a. Identification Card (Company's ID/Driver's Licence/PRC ID/SSS ID)
  - b. lead pencil
  - c. blue and black pen
  - d. pack lunch/snacks
4. There will be three (3) testing sessions which will start at 8:00 o'clock in the morning and ends at 5:00 o'clock in the afternoon. The test will last one (1) hour and thirty minutes (30 min.)
5. The District Supervisor and the Central School Principal of Minglanilla District I is advised to prepare the testing venue specifically, testing rooms and holding areas of the

6. The Division Testing Coordinator will act as Chief Examiner. Elementary and Secondary Lead School Principals will be utilized as Room Examiners while Division Supervisors/Coordinators will serve as Room Supervisors.

Travelling and other expenses such as snacks, lunch and accommodation of the Bureau of Educational Assessment (BEA) and of all personnel involved in the administration of the EPT shall be charged against the Division Training Fund, subject to its availability and the usual accounting and auditing rules and regulations.
