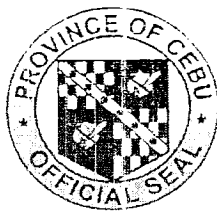

RESOLUTION NO. 319-2016

AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

URGING THE DEPARTMENT OF EDUCATION REGION VII (DepEd VII), DEPARTMENT OF HEALTH (DOH), AND ALL BARANGAY HEALTH CENTERS AND MUNICIPALITIES IN CEBU PROVINCE TO CONDUCT CONCERTED AND COORDINATED EFFORTS IN COMBATING AGAINST DENGUE AND ZIKA VIRUS.

WHEREAS, DILG Memorandum Circular No. 2008-22 reiterating DILG's Memorandum Circular No. 2005-74 which asks all Provincial Governors, City and Municipal Mayors, Punong Barangays, DILG Regional Directors and all other concerned to support the Department of Health: (A) to conduct an intensified massive information and education campaign on dengue fever with emphasis on environmental control of breeding sites especially in endemic areas; (B) to identify potential breeding places of dengue carrying mosquitoes and carry out appropriate preventive and control measures, enforce environmental sanitation such as dredging of clogged canals, esteros and other waterways, pruning thick bushes/tree branches, and removal/drainage of receptacles containing stagnant water;

WHEREAS, the British Broadcasting Corporation (BBC) reported that a Professor from the Brazilian Academy of Sciences and of London School of Hygiene and Tropical Medicine says that there is a real chance that the virus would hit Asia. The same report also contains an expert's statement which states that "where there is dengue, there would Zika virus be.";

WHEREAS, the coordinated efforts aim primarily on providing the public with correct and sufficient information regarding Dengue and more on Zika virus for this poses a great deal of

constant risk to all, especially to all pregnant woman. By equipping the public with the right and sufficient knowledge regarding the said viruses, they can respond with their own initiatives in preventing this virus to spread;

WHEREAS, this august Body believes that it is just high time to re-educate and warn the public regarding the said virus so that the public will know what to do to help the health care agencies in their preventive measures in addressing this new onslaught of mosquito born disease;

NOW THEREFORE, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Presiding Officer Pro Tempore, **Hon. JULIAN B. DAAN**, for the approval of the resolution authored by Member, **Hon. MIGUEL ANTONIO A. MAGPALE**, be it

RESOLVED as it is hereby **RESOLVED**, to urge the Department of Education Region VII (DepEd VII), Department of Health (DOH), and all Barangay Health Centers and Municipalities in Cebu Province to conduct concerted and coordinated efforts in combating against Dengue and Zika virus;

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of Governor Hilario P. Davide III, Department of Education Region VII (DepEd VII), Department of Health (DOH) and to all Barangay Health Centers and Municipalities-Cebu Province.
