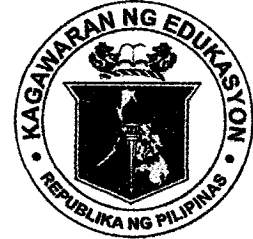



URGING THE DEPARTMENT OF EDUCATION - REGION VII (DEPED VII), TO STRICTLY CAMPAIGN AGAINST GIVING OF EXPENSIVE ASSIGNMENTS, PROJECTS AND RESEARCH PAPERS TO ELEMENTARY PUPILS MOST ESPECIALLY DURING WEEKENDS.

WHEREAS, Article 2, Section 12 of the 1987 Philippine Constitution provides that, *"the State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution, and the natural and primary right and duty of parents in the rearing of the youth for civic efficiency and the development of moral character shall receive the support of the Government";*

WHEREAS, Article 14, Section 2 (2) of the 1987 Philippine Constitution provides that, *"the State shall establish and maintain a system of free public education in the elementary and high school levels";*

WHEREAS, Paragraph 4 of DepEd Memo No. 392-2010 otherwise known as, *"Guidelines on Giving Homework or Assignments to all Public Elementary School Pupils"* provides that, *"no homework/assignments shall be given during weekends for pupils to enjoy their childhood, and spend quality time with their parents without being burdened by the thought of doing lots of homework";*

WHEREAS, the herein stated memorandum was issued upon the premise that when pupils are given assignments during weekends, it would rub the parents' quality time for their child/children; therefore parents' effort to spend quality time for their child/children is likewise urged for;

WHEREAS, this august Body believes in the significance of affordable, if not free, public education for elementary and high school students, so as to encourage economically challenged families to send and/or continue sending their child/children to school;

NOW, THEREFORE, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Assistant Majority Floor Leader, **Hon. CHRISTOPHER R. BARICUATRO**, for the approval of the resolution authored by Member, **Hon. MIGUEL ANTONIO A. MAGPALE**, be it;

RESOLVED, as it is hereby **RESOLVED**, to urge the Department of Education - Region VII (DepEd VII), to strictly campaign against giving of expensive assignments, projects research papers to Elementary Pupils most especially during weekends;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the Governor, Hilario P. Davide III, Cebu Provincial Information Office (PIO), and to the Department of Education - Region VII (DepEd VII).


