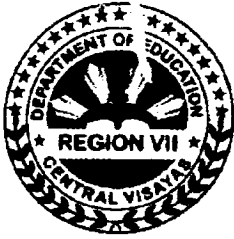

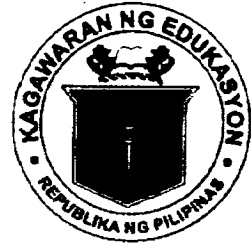

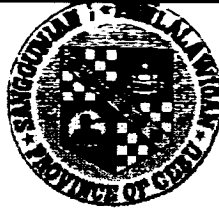

REQUESTING THE DEPARTMENT OF EDUCATION – REGION VII (DEPED VII) AND COMMISSION ON HIGHER EDUCATION – REGION VII (CHED VII), TO CONDUCT OR CONSIDER THE INCORPORATION OF REGULAR EMERGENCY RESPONSE / FIRST AID TRAININGS IN THEIR CURRICULUM, FOR ALL STUDENTS IN THE PROVINCE OF CEBU.

WHEREAS, the preservation of life during an emergency situation is an important skill that may be acquired through proper instruction;

WHEREAS, knowledge of first aid remedies or emergency medical procedures such as Cardiopulmonary Resuscitation (CPR) and Heimlich Maneuver could prevent unnecessary loss of life, but sadly, not everyone knows how to conduct the same which could have been done by anyone regardless if they have any medical background;

WHEREAS, recently, a video clip of a victim who drowned and was dragged back to the beach for resuscitation is circulating on cyberspace;

WHEREAS, watching the above-mentioned video would make anyone with a medical background cringe, because in the said video, the victim was tossed and flipped around with hopes that such would drain the water out of his lungs, but such efforts were obviously futile;

WHEREAS, knowledge of such remedies or simple medical procedures is best to be taught in schools incorporating the same in their curriculum, as this would convey important knowledge to our students which they can use to save lives when the need arises;

WHEREAS, premises considered, this august Body finds it imperative to request DepEd and CHED to conduct or consider the incorporation of regular emergency response/ first aid trainings in their respective curriculum of the schools in the Province of Cebu;

WHEREAS, such request is in line with Section 16 of the 1991 Local Government Code of the Philippines, which mandates all Local Government Units in the Philippines to promote the health and safety of its inhabitants;

NOW, THEREFORE, on motion of Majority Floor Leader, **Hon. JUDE THADDEUS DURANO SYBICO**, duly seconded by Assistant Majority Floor Leader, **Hon. CHRISTOPHER R. BARICUATRO**, for the approval of the resolution authored by Member, **Hon. VICTORIA COROMINAS-TORIBIO** and co-authored by Member, **Hon. ALEX S. BINGHAY**, be it

RESOLVED as it is hereby **RESOLVED**, to request the Department of Education – Region VII (DepEd VII) and Commission on Higher Education – Region VII (CHED VII), to conduct or consider the incorporation of Regular Emergency Response / First Aid Trainings in their curriculum, for all students in the Province of Cebu;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Offices of DepEd and CHED Region VII for their information and guidance.
