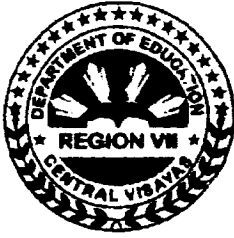

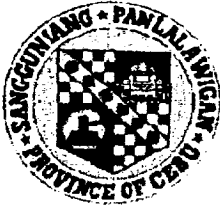

**WHEREAS**, this August Body believes in the significance of making emphasis and priority on academic learning over extracurricular activities, most specially that there are many holidays prior to the actual Sinulog celebration;
