RESOLUTION NO. 1762-2016

AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

HUMBLY REQUESTING THE DEPARTMENT OF EDUCATION - REGION VII (DEPED VII), TO INCORPORATE THE ANTI-CHILD PORNOGRAPHY ACT OF 2009 IN THE REPRODUCTIVE HEALTH EDUCATION PROGRAM.

WHEREAS, Article 15, Section 3 of the 1987 Philippine Constitution provides that, "the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development";

WHEREAS, child pornography, as provided in Section 3(b) of Republic Act No. 9775, otherwise known as, "An Act Defining the Crime of Child Pornography, Prescribing Penalties Therefor and for Other Purposes", refers to any representation whether visual, audio, or written combination thereof, by electronic, mechanical, digital, optical, magnetic or any other means, of child engaged or involved in real or simulated explicit sexual activities";

WHEREAS, Section 14 of Republic Act No. 10354, otherwise known as, "An Act Providing for a National Policy on Responsible Parenthood and Reproductive Health" provides that, "the State shall provide age and development-appropriate reproductive health education to adolescents which shall be taught by adequately trained teachers in formal and non-formal

educational system and integrated in relevant subjects such as, but not limited to, values formation; knowledge and skills in self-protection against discrimination; sexual abuse and violence against women and children and other forms of gender based violence...";

WHEREAS, there have been alarming incidents of child pornography in the Province of Cebu, not only perpetrated by foreigners, but also of parents themselves;

WHEREAS, this august Body believes in the significance of educating the public, most especially the young ones, so as to foster a safe and child pornography free Province of Cebu;

NOW, THEREFORE, on motion of Majority Floor Leader, Hon. **JUDE THADDEUS DURANO SYBICO**, duly seconded by Assistant Majority Floor Leader, Hon. **CHRISTOPHER R. BARICUATRO**, for the approval of the resolution authored by Member, Hon. **MIGUEL ANTONIO A. MAGPALE**, be it;

RESOLVED, as it is hereby **RESOLVED**, to humbly request the Department of Education - Region VII (DepEd VII), to incorporate the Anti-Child Pornography Act of 2009 in the Reproductive Health Education Program;
