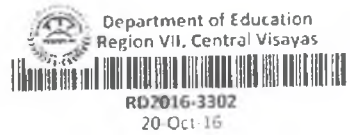

RESOLUTION NO. 2030-2016

AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

URGING THE DEPARTMENT OF EDUCATION – REGION VII (DEPED VII) AND ALL LOCAL GOVERNMENT UNITS’ COMMITTEE ON EDUCATION IN THE PROVINCE OF CEBU, TO CREATE FORTIFIED AND COORDINATED EFFORTS TO RAISE AWARENESS ON CHILDREN’S RIGHTS.

WHEREAS, Article 2, Section 15 of the 1987 Philippine Constitution provides that, “the State shall protect and promote the right to health of the people and instill health consciousness among them”;

WHEREAS, Article 15, Section 3 (2) of the 1987 Philippine Constitution provides that, “the State shall defend the right of the children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development”;

WHEREAS, Presidential Proclamation No. 267, S. 1993, otherwise known as “Declaring the Month of October of Every Year as National Children’s Month”, aims to make an “emphasis the importance of the role of the child within the Filipino family and within the Philippine society by commemorating the Filipino children on every month of October”;
