## BASA PILIPINAS REINFORCING EFFECTIVE LITERACY INSTRUCTION IN GRADE 2 CLASSROOMS TRAINING OF TRAINERS (TOT)

- 1. This Office announces the conduct of the *Basa Pilipinas* Reinforcing Effective Literacy Instruction in Grade 2 Classrooms Training of Trainers (ToT) on November 24-26, 2016 at Golden Prince Hotel and Suites, Cebu City.
- 2. Please refer to the Enclosure for the List of Participants.
- 3. This training aims to:
  - a. review effective instructional practices and the 14 Domains of Literacy;
  - b. re-examine the Revised Teacher's Guides and prepare a Daily Lesson Log (DLL);
  - c. discuss classroom assessment and gain a better understanding of the kind of assessment found in the Revised Teacher's Guides;
  - d. revisit the Read-alouds and the Leveled Readers and address common challenges encountered in using them;
  - e. share best practices to effective classroom management; and
  - f. finalize plans for the rollout training on *Basa Pilipinas* Reinforcing Effective Literacy Instruction in Grade 2 Classrooms Training of Trainers (ToT).
- 4. Please take note of the following:
  - This is a live-in activity.
  - Arrival of participants is on day 1, except for teachers from Bantayan and Camotes Islands who may check in on day 0 (November 23).
  - Registration starts at 7:30 am of day 1 (November 24) and check out is on day 3 (November 26).
  - Arranged meals at the venue will start on day 1, AM snacks.
  - Bringing of a family member to the venue is not allowed.
  - Participants are responsible for their own maintenance medicines and vitamins.
- 5. Only round-trip transportation expenses shall be reimbursed with boat, bus and taxi receipts as attachments.

- 6. Teaching personnel shall be granted **Service Credits** tantamount to the services rendered during non-school day, as reflected in the daily attendance sheets, while non-teaching personnel are entitled to a **Compensatory Time Off (CTO)** benefit for their involvement in the said training on Saturday, November 26.
- 7. Traveling, hotel accommodation, meals, snacks and other expenses relative thereto, shall be chargeable against **USAID** *Basa Pilipinas* Funds, subject to availability and the usual accounting and auditing rules and regulations.
- 8. This Memorandum serves as Authority to Travel.
