LAUNCHING THE FOURTH DEPED EMPLOYEES' REGIONAL INTER-DIVISION/DISTRICT BASKETBALL, VOLLEYBALL, LAWN TENNIS AND BADMINTON TOURNAMENT

To : Schools Division Superintendents

1. To continue the Physical Fitness Program of the DepEd Employees in the Region, in coordination with the **DepEd RO7 Multi-Purpose Cooperative**, the **Fourth DepEd Employees'** Regional Inter-Division/District Basketball Tournament (2 age-level categories), Volleyball, Lawn Tennis and Badminton Tournament (men and women open-age categories) shall be launch on December 18, 2016 (Sunday) at 8:00 AM at Zapatera Elementary School, Cebu City the host Division for this year's tournament. It will start with the registration, to be followed with a simple parade, short program, search for Miss DERESA 2016 and three (3) games per event. Each team shall be responsible of their own provisions.

2. FIBA, FIVB, Lawn Tennis and Badminton Rules shall be followed respectively, however, the committee can modify the rules as the need arises. The Committee's decision is, at all times, final.

3. During Registration, the team shall:

- * be in complete line-up wearing the tournament uniform.
- * bring all the requirements (official line-up, Medical Certificate/waiver, certificate of Employment, DepEd I.D.-photocopy and duly accomplished membership form).
- * full payment of P 8,000.00 for basketball 37 & below category, P 7,000.00 for Basketball 38 & above category, P 6,000.00 for volleyball men and women category, P 500.00 per player for Lawn tennis and Badminton men and women category.
- Early registrants will be accepted through the above-mentioned cooperative.

4. The registration fee, uniform and transportation expenses and other relative to these activities shall be from <u>personal/stakeholders</u> funds or may be charged against <u>Region/Division</u> <u>MOOE/SEF/PTA/GAA/GAD/ or other</u> funds subject to the usual accounting and auditing rules and regulations.

5. Enclosed are the Ground Rules and Regulations of the Tournament and the letter of Mr. Adriano R. Regulacion Jr., President, DepEd Region VII Employees Sports Association (DERESA), informing this Office of the tournament.

DEPED REGIONAL BASKETBALL, VOLLEYBALL, LAWN TENNIS AND BADMINTON TOURNAMENT

RULES AND REGULATIONS

I.ELIGIBITY

- A. The tournament is exclusive to all DepEd Employees in the region teaching and non-teaching personnel (public and Ecotech employees).
- B. Must be an active member of the association by accomplishing the membership form and membership fee of P 100.00/member annually.
- C. Each player must submit a medical certificate/waiver, certificate of employment and DepEd I.D.-photocopy).

II. TOURNAMENT FORMAT

- A. Basketball (men only)
 - 1. 37 years old and below category
 - * 15 active players and 2 reserved players
 - 2. 38 years old and above category
 - 15 active players and 2 reserved players
- B. Volleyball (men and women)
 - 1. Men category, 12-14 players
 - 2. Women category, 12-14 players
- C. Lawn Tennis (men and women)
 - 1. Men category, 4 players
 - 1 player for single A, 1 player for single B, 2 players for doubles.
 - 2. Women category, 4 players
 - 1 player for single A, 1 player for single B, 2 players for doubles
- D. Badminton (men and women)
 - 1. Men category, 4 players
 - 1 player for single A, 1 player for single B, 2 players for doubles.
 - 2. Women category, 4 players
 - 1 player for single A, 1 player for single B, 2 players for doubles

III. TOURNAMENT RULES

- A. Participating teams in basketball must have 15 active players and 2 reserved players less than 15 players during the game will be penalized with 2 points additional score to their opposing team per player.
- B. Must pay the registration fee during the opening program.
- C. The player must wear their official uniform during the opening program and in every game. (no official uniform during the game, no play).
- D. Games shall be played as scheduled. Therefore, the team must arrive at the venue 1 hour before the start of their game.
- E. Barangayan format will be used in both categories, no substitution in the first to third period, substitution is allowed in the fourth quarter.
- F. A single round robin format is adapted in this tournament. The top 4 teams will play in a knock out semi-final, 1 VS 4 and 2 VS 3, in case of more than ten (10) teams in their category, bracket A and B shall be used. Top 2 teams in each bracket will advance to the knock out semi-finals, # 1 in bracket A VS # 2, # 2 in bracket A VS # 1 in bracket B.

The winner will advance to the championship round and the loser will play for 3rd place in a knock out game (no twice to beat advantage).

- G. The following tie-break system, in descending order of priority, shall be used to determine the final ranking of the teams.
 - a. Direct Encounter (win over the other)
 - b. For triple ties/multiple ties, the average or quotient system shall be the basis to break the tie.
- H. Every game shall be played ten (10) minutes per period. But may be modified as the need arises.
- I. Games will be played during Saturday 8:00 AM 5:00 PM, Sunday from 8:00 AM-12:00 PM and holidays.
- J. For Volleyball, Lawn Tennis and Badminton, tournament rules will be discussed during the solidarity meeting right after the opening program.
