

The examination shall cover situational critical thinking questions relevant to the role of a SH anchored on the domains of the **National Competency-Based Standards for School Heads (NCBSSH)** stipulated in DepEd Order (DO) No. 32, Series of 2010 entitled National Adoption and Implementation of the National Competency-Based Standards for School Heads:

1. School Leadership;
2. Instructional Leadership;
3. Creating Student-Centered Learning Climate;
4. Human Resource Management and Professional Development;
5. Parent Involvement and Community Partnership;
6. School Management and Operations; and
7. Personal and Professional Attributes and Interpersonal Effectiveness.
