1. Pursuant to **DepEd Order No. 55, series of 2016**, entitled “**Policy Guidelines on the National Assessment on Student Learning for the K to 12 Basic Program**”, specifically Section 4, letter e: Grade level Placement assessment for learners in special circumstances specified in Section 6 to determine their appropriate grade level in the formal system, the division are directed to:
 - a. Require all private schools operating without permit to submit the list of learners by grade level for the Philippine Validation Test.
 - b. Convene all private elementary and secondary school heads and agree on the preferred schedule of the validation test to be able to determine the appropriate level of the learners in the formal system.
 - c. Consolidate and submit to this office on or before **May 2, 2017** for endorsement to the Bureau of Education Assessment at DepEd Central Office.
 - d. All expenses incurred relative to the said activity shall be shouldered by the private schools concerned.
