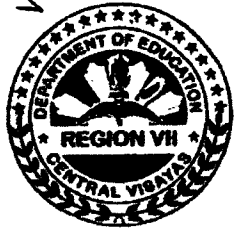

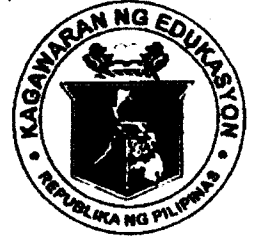

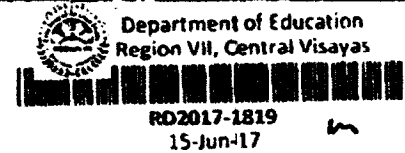

A Petition for Accreditation has been filed with the Civil Service Commission by the **Alliance of Concerned Teachers – Region 7 Union (ACT-REGION 7 UNION)** of the Department of Education Regional Office No. VII (DepEd RO VII), Cebu City.


Pursuant to **Section 7, Rule VIII of the Amended Rules and Regulations Governing the Exercise of the Right of Government Employees to Organize**, within the 10-day posting period, any interested party may file with the CSC-HRRO, copy furnished the petitioner-employee association, a sworn opposition to the petition for accreditation on grounds of misrepresentation, false statement or fraud in connection with the names and signatures of the rank-and-file employees appearing in the petition.

In filing a sworn opposition to the petition for accreditation of the **ACT-REGION 7 UNION**, the following requirements shall be present:

1. The name/s and address/es of the oppositor and, if representing an organization, include the name of the organization and the details of its registration with the DOLE-BLR and CSC;
2. A statement that the sworn opposition is filed within the 10-day posting period;
3. The specific violations committed as properly covered by the above-stated grounds, and any document/s supporting the allegations; and
4. The relief/s prayed for.

Section 8 of the abovementioned Rule provides that if no opposition is filed, the CSC-HRRO shall cause the preparation of a certificate of accreditation for signature of the Chairperson of the CSC.

This Notice shall be posted along with the sworn petition/resolution for accreditation of the petitioner-employees association, the support signatures and the notice of petition for accreditation, in a conspicuous place within the premises of the DepEd RO VII, and in elementary and secondary schools of the districts/divisions covered by DepEd RO VII for a period of ten (10) calendar days.

NOTICE OF PETITION FOR ACCREDITATION

This serves as notice that a Petition for Accreditation has been filed with the Civil Service Commission by the **Alliance of Concerned Teachers – Region 7 Union (ACT-REGION 7 UNION)** of the Department of Education Regional Office No. VII (DepEd RO VII), Cebu City.

Pursuant to Section 7, Rule VIII of the Amended Rules and Regulations Governing the Exercise of the Right of Government Employees to Organize, any interested party may file an opposition to the petition *within ten (10) calendar days* from the posting of this Notice. An opposition to the petition for accreditation of the petitioner-employees association shall be entertained upon filing with the CSC-HRRO, copy furnished the petitioner-union, of a sworn opposition to the petition for accreditation.

After the 10-day period, the petitioner-employees association shall submit to the Human Resource Relations Office of the Commission a report under oath on the presence/absence of any opposition to the petition. If no opposition is filed within the prescribed period, a Certificate of Accreditation shall be issued to the petitioner-employees association.

Furthermore, after the expiration of the 10-day posting period, any contesting registered employees' organization in the DepEd RO VII which failed to file an opposition to the petition for accreditation of the ACT-REGION 7 UNION within the posting period, shall be deemed barred.

Attached is the notice to the oppositor together with the sworn petition/resolution for accreditation and the support signatures of the majority of the rank-and-file employees of the DepEd RO VII.

This Notice and the abovementioned attachments shall be posted in a conspicuous place within the premises of the DepEd RO VII, and in elementary and secondary schools of the districts/divisions covered by DepEd RO VII for a period of ten (10) calendar days.

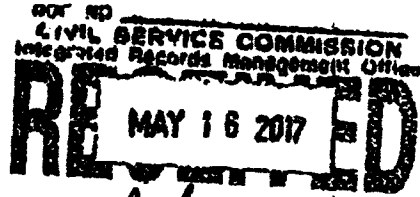
