**DATE :** June 5, 2017

*Palarong Pambansa*, as the country's premier national sporting event, is a breeding ground for international competitions. Thus, any event related and/or leading to the same shall be formulated and conducted in accordance with international standards.

It has come to our office's knowledge that various sports seminars and trainings are being conducted using DepEd resources and funds without necessary clearance and authorization from this office or the Department.

In this regard, this memorandum shall cover all trainings, seminars, or any related events, whether regional or division-wide, on Palaro sports event where DepEd personnel are invited as participants.

Rule II, Section 8 (a) and (b) of the *Palarong Pambansa Law Implementing Rules and Regulations (IRR)* mandates the Palarong Pambansa Board "to formulate policies and guidelines that shall govern the conduct of Palarong Pambansa and other related school-based activities leading to Palarong Pambansa" as well as "to review and update regularly the rules and regulations of the sports included in the Palarong Pambansa in accordance with international standards."

Section 9 (c) of the same Rule, on the other hand, authorizes the *Palarong Pambansa Secretary General* to "implement, coordinate and monitor the policies and plans formulated by the Board."

Accordingly, to ensure that all trainings, seminars, lectures, workshops, or any related event, whether regional or division-wide, on Palarong Pambansa sports (where DepEd personnel are invited as participants) shall cover topics and lectures that meet international standards, the organizers of such activities should secure prior clearance from the Office of the Palarong Pambansa Secretary General. Otherwise, such events shall not be recognized or be considered as an authorized event where the DepEd personnel who participated can earn any form of professional benefit, qualification or credit in connection with Palarong Pambansa.

Finally, participation of DepEd personnel in abovementioned activities or events shall only be officially authorized if such activities or events are sponsored and/or actually conducted by entities or organizations; sports officials and instructors who are qualified to organize such activities or events and to teach and lecture topics that are consistent with international Olympics sports standards.
